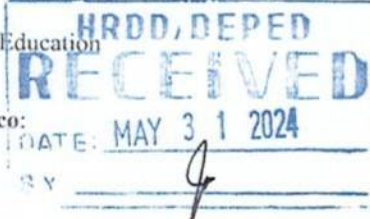

3. Develop their interest and active participation in conducting research in Home Economics and related disciplines.


