**ADDITIONAL ALLOCATION FOR SCHOOL MOOE FOR FY 2024**

1. In reference to FSBD-2024-013 and MOUF-2024-013 pertaining to the provision of additional allocation for Maintenance and Other Operating Expenses (MOOE) to public Elementary, Junior and Senior High Schools, this to inform the schools listed on **Annex A** of their additional MOOE allocation this CY 2024.
2. The additional MOOE allotment is intended to adjust the MOOE allocation provided under the FY 2024 GAA, which includes the MOOE allocation for newly-established schools, newly converted integrated schools, and schools with new curricular offerings based on the latest data reported on the LIS for SY 2023-2024 as of January 31, 2024.
3. The use of this additional MOOE shall be subject to the provisions stated on DepEd Order No. 8, s.2019 entitled Revised Implementing Guidelines on the Direct Release, Use, Monitoring and Reporting of MOOE and Other Funds Managed by Schools.
4. Be it noted that in the release of this additional MOOE, concerned schools should update their PPMP, APP and AIP/WFP for the additional PPAs to be funded in the use of this additional funds.
5. In the issuance of this memorandum, there shall be no discrimination in the provision of the Learning and Development on account of age, school, gender, civil status, disability and religion or other similar factors/personal circumstances that run counter to the principles of equal opportunity.
