**PARTICIPATION IN THE FILIPINO CHILD: AN ONLINE DIALOGUE ON STRENGTHENING THE MENTAL HEALTH SAFETY PLANS IN SCHOOLS**

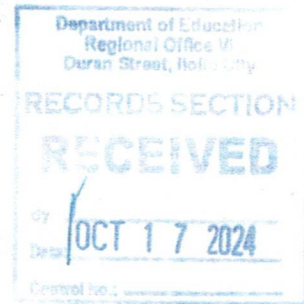

Greetings!



For the past 27 years, Bantay Bata 163 has continued its commitment to helping schools and communities build an environment that is safe for children - where their rights are protected, and where their mental health is valued. These initiatives are carried out in collaboration with government and non-government agencies, as well as academic institutions, to ensure the success and effective service delivery to the community.

Currently, we have concentrated our efforts on providing support through our four core projects: (1) the **Bantay Bata Helpline 163**, a helpline that is dedicated to responding to and providing support to any child-related concerns; (2) the **Child Safe Philippines Project**, which aims to guide and capacitate schools and communities in creating a localized Child Protection Policy, Programs and reporting Protocols; (3) the **Children and Youth Advocacy Council**, a project that highlights the importance of child participation in the development of programs for and by the children; and (4) **Project MIND** which seeks to promote and raise awareness on mental health and tries to address the gaps in mental health provision through capacity building of volunteer mental health and psychosocial support service providers.

In implementing one of our projects, particularly Project MIND, we have seen the importance of raising awareness about mental health among students and their families to break the stigma associated with it, as well as **strengthening the mental health safety plans in schools** for students experiencing mental health and other psychosocial difficulties. Schools, particularly junior and senior high schools, have expressed the need for mental health services for learners who have expressed suicidal ideations and in preventing and responding to cases of suicide in schools. In line with this, we are organizing the third year of implementation of **THE FILIPINO CHILD** on **November 8, 2024 (Friday), 9:00 AM - 12:00 NN** via **Zoom**.

Started in 2022, **The Filipino Child (TFC)**, is an online dialogue with community partners and stakeholders that provides a platform for open and inclusive discussions to raise awareness and address the pressing issues affecting children and youth. This year's National Dialogue seeks to foster discussions to provide information on suicide prevention and service provision to learners, and ultimately guide the schools in creating a school-based suicide prevention and response plan.
