

Pursuant to the goal of DepEd Order No. 40, s. 2012 or the Child Protection Policy to strengthen the functionality of the Child Protection Committees (CPC) in schools for the protection of the rights of the learners and from any forms of violence and abuse, this Office, through the Education Support Services Division (ESSD), shall conduct the **Regional Learner Rights and Protection (LRP) Specialization Course: Retooling of Child Protection Committees (CPC) on Child Protection Functionality** on **January 28-31, 2025** at **Grand Xing Imperial Hotel, Iloilo City**.
