1. The Schools Division of Sagay will participate in the 29th Sinigayan Festival **2025 Drum and Lyre Competition** on **March 16, 2025**.
2. This activity aims to promote musical excellence and discipline among students and showcase the musical talents of students through band and lyre performances.

4. All teachers who will be participating in the band and lyre rehearsals and practice during weekend shall receive appropriate service credits as stipulated in DepEd Order (DO) No. 53, s. 2003, upon submission of DTR after the program to the SGOD – SocMob for proper endorsement. Signing in the attendance sheet shall be done after the program. No submission of separate DTR as discussed during DCEL.
5. The teacher-adviser / coach shall ensure the submission of parental consent of the learners who will be attending the activity (please see attached form).
6. It is understood that in the conduct of this activity there shall be no discrimination in the provision of such partnership on account of age, school, gender, civil status, disability, religion or other similar factors, personal circumstances that run counter to the principles of equal opportunity.

2025 BAND AND LYRE COMPETITION
MECHANICS AND GUIDELINES**

• **DEFINITION:**

The Band and Lyre Competition is a musical event where school bands and lyre ensembles showcase their musical skills, coordination, and creativity through performances. This competition aims to promote musical excellence, teamwork, and appreciation for instrumental music while fostering camaraderie among participants.

• **ELIGIBILITY:**

- Open to all public and private school bands and lyre ensembles.
- Each group must consist of at least 30 members and not exceed 100 members.
- Participants must submit their Application form (Annex B of this memo) on or before March 7, 2025.

• **PERFORMANCE GUIDELINES:**

- Each team is allotted with a maximum of 12 minutes for their performance, including entrance and exit.
- Teams can perform a medley of songs or a thematic composition showcasing traditional, popular, or cultural pieces.
- Choreography and formations should be safe and within the designated performance area.

• **ATTIRE AND EQUIPMENT:**

- Uniforms should be well-coordinated, presentable and appropriate for public performance.
- Only drums and lyres are allowed; Mechanical instruments, electronics or motor engines are not allowed.
- Only batons and flags and other props such as pompoms, banners, and alike are allowed to be used. Ten points will be deducted from the total points of the team violating this guideline.
- Groups are responsible for their own instruments and props.

• **JUDGING CRITERIA:**

- The Drum & Lyre Group and the Majorette Corps shall be judged as one competing unit. 70% of the aggregate score of the Drum & Lyre Group and 30% of the aggregate score of the Majorette Corps shall be the total points earned. The total points shall be the basis for the final ranking.
- No deduction shall be made for the dropping of baton.
- Judging and time count shall commence from the start of the first beat excluding entry into the performance area. All performances should not be less than five minutes and

not exceed ten minutes. Ten points shall be deducted from the total score if the duration of the performance is not within the time limit.

- No coach, school head, or school coordinator shall be allowed to go near the judges.
- Criteria of Judging is as follows:

DRUM AND LYRE (70%)

• Master Piece	30%
(Precision of attacks and release, rhythm and tempo)	
• Total Quality (Clarity and harmony)	25%
• Interpretation (Technique, style and choreography)	25%
• General Impact (Smartness in uniform and deportment)	<u>20%</u>
Total	100%

• **MAJORETTE CORPS (30%)**

• Baton Twirling	35%
• Style and Interpretation	30%
• Choreography	20%
• General Impact	<u>15%</u>
Total	100%

• **GENERAL RULES:**

- Unsportsmanlike conduct from participants or supporters will result in penalties or disqualification.
- All decisions by the judges are final and non-contestable.
- Any changes to the performance details must be communicated in advance.
