The Fulbright Foreign Student Program offers scholarship opportunities for Filipinos to study at the graduate level (master's or doctoral studies) or pursue non-degree doctoral dissertation research on identified fields of study in the United States. The grant provides for round-trip international travel, monthly maintenance allowance, tuition and fees, book/supplies allowance, and health and accident insurance.
