1. This office would like to inform everyone about the **inclusion of the Baseball Elementary Athletes and Coach in the Division of Iloilo's official roster** for the WVRAA team that will compete in the 2025 Palarong Pambansa, to be held in Ilocos Norte Province from March 24 to June 2, 2025.

3. **The coach** is requested to facilitate the securing of parental permits for the athletes to participate in this activity and to ensure their safety and protection. Additionally, the coach must maintain direct contact with the official coach of the Division of Iloilo and ensure that the athletes are not left unattended during training and competition.

4. **The School head** is tasked with ensuring that athletes do not fall behind in their academic performance and that learning continues despite their training schedule. Athletes must be given special tests, performance tasks, and other academic requirements while they are in training. At the same time, the coach's teaching responsibilities must be adjusted accordingly to allow full focus on training the athletes.

5. The travel, incidental, food, accommodation, and training expenses of the said athletes and coach shall be chargeable against the Region VI sports funds, Negros Occidental SEF funds, and LGU Sagay City SEF funds. Any expenses not covered by these funds may be charged to the School MOOE, subject to its availability and in accordance with the usual accounting and auditing rules and regulations

6. It is understood that in the conduct of this activity, there shall be no discrimination on account of age, school, gender, civil status, disability, religion, or other similar factors, or personal circumstances that run counter to the principles of equal opportunity.
