1. Relative to Memorandum OM-OUOPS-2025-05-01337 on the Guidelines on the Eligibility of Athletes and Regional Memorandum No. 235, s. 2025, titled *Schedule of Activities of the Regional Screening and Accreditation Committee (RSAC)*, the **National Screening and Accreditation Committee (NSAC) will conduct an ocular inspection and interview of all qualified athletes, coaches, assistant coaches, and chaperones** in preparation for the 2025 Palarong Pambansa **on April 2, 2025, at the Food Terminal in Bacolod City.**

2. Below is the list of qualified athletes, coaches, and chaperones who will undergo the ocular inspection and interview. This memorandum serves as the official travel authorization for athletes and coaches; however, coaches must secure approval or a Travel Order from their respective School Heads.

3. **The coach** is requested to facilitate the acquisition of the documentary requirements for the athletes' eligibility and to prepare any other necessary documents.

4. **The School Head** is responsible for ensuring that all qualified athletes maintain their academic performance while undergoing the ocular inspection and interview. During this period, athletes must be provided with special tests, performance tasks, and other academic requirements as necessary. Similarly, the **teaching responsibilities of coaches** should be adjusted accordingly to allow them to fully participate in the screening process.

5. The travel, incidental, food, expenses of the athletes and coaches shall be chargeable against LGU Sagay City SEF funds subject to its availability and in accordance with the usual accounting and auditing rules and regulations.

6. It is understood that in the conduct of this activity, there shall be no discrimination on account of age, school, gender, civil status, disability, religion, or other similar factors, or personal circumstances that run counter to the principles of equal opportunity.
