1. The City Government of Sagay and DepEd Division of Sagay City will celebrate the **83<sup>rd</sup> Araw ng Kagitingan** on **April 9, 2025 @ 7:00 a.m.** The program will be conducted beside the Veteran's Monument, with the theme: **"Kabayanihan ng Beterano: Sandigan ng Kaunlaran ng Bagong Pilipinas."**

2. The celebration commemorates the bravery and sacrifices of Filipino and American soldiers during the Battle of Bataan in 1942, which was a significant event in World War II. It also serves as a reminder of the bravery and sacrifices of these soldiers, who risked their lives in the defense of our country and their fellow citizens. It honors the spirit of heroism and patriotism that continues to inspire and unite the Filipino people.
