**TRIAL ASSESSMENT AND PCMT TRAINING FOR OUR CHILDREN'S FEEDING
BY THE CONVOY OF HOPE IN SDO SAGAY**

1. The SDO Sagay, in partnership with **Convoy of Hope Philippines**, shall conduct Trial Assessment and PCMT Training for Children's Feeding Program on **April 22, 2025 at SDO Sagay City Annex Building, 1:00 PM.**

2. The objectives of this engagement is to ensure all necessary requirements for the Children's Feeding Program are met, evaluate the readiness of Program Centers/Schools for continuous feeding five times a week for one year, measure the impact of our feeding initiatives on the target beneficiaries, identify and brainstorm solutions for any obstacles encountered, exchange successful strategies implemented by various partners, strategize for the next phase of the program to ensure alignment with our goals and objectives, and require Regular Program Centers to submit hard copies of the Child Nutritional Status based on the submitted number of learners (Baseline and Endline).

3. The participants for this are the following:

- School Heads or its authorized representative;
- Feeding Coordinator;
- Barangay Representative and Local Government Unit or its authorized representative
- PTA President

4. Expense incurred of the participants shall be charged against MOOE or any available school local funds subject to the usual government accounting and auditing rules and regulations.

5. It is understood that in the conduct of this activity, there shall be no discrimination based on age, school, gender, civil status, disability, religion, or other similar factors, or personal circumstances that run counter to the principles of equal opportunity.
