1. In accordance with DepEd Memorandum No. 047, s. 2024 titled Supplemental Guidelines on the Utilization of Additional Downloaded Fiscal Year 2023 Flexible Learning Options Funds for the Procurement of Tablets, this Office announces the Delivery and Distribution of Tablets for Alternative Learning System (ALS) Learners, Alternative Delivery Mode (ADM) Open High School Program (OHSP) Learners, and Learners on High-Risk Disaster-Prone Areas by the GAP Import and Export Corporation to the identified school/community learning centers.
2. The Regional Supply Officer will coordinate with the Division/School Supply Officers should the former receive notice of delivery from the supplier. The link for the allocation lists may be accessed through tinyurl.com/ALSADMTABRecipients.
3. The Recipient Schools and the Community Learning Centers must secure a storage area intended for the delivery of the tablets and ensure that their authorized personnel are available during the scheduled delivery date. Further, all pertinent documents should be accomplished by the following authorized signatories:

Considering that teachers may be involved in the activity scheduled during their vacation, they are entitled to Service Credits for their services but not to exceed 15 days in accordance with DepEd Order No. 53, s. 2003 entitled "Updated Guidelines on the Grant of Vacation Service Credits to Teachers."
5. The expenses incurred relative to the conduct of the activity, including travel, to submit to this Office the documents needed for the payment of this project are chargeable against local/PSF funds subject to the usual government accounting and auditing rules and regulations.
