

The participants are entitled to vacation service credits in accordance with DepEd Order No. 13, s. 2024 "*Revised Guidelines on the Grants of Vacation Service Credits for Teachers*" or DepEd Order No. 009, s. 2025 "*Amendment to DepEd Order No. 009, s. 2024 (Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025)*," or compensatory time-off pursuant to CSC-DBM Joint Circular No. 2, s. 2004 "*Non-Monetary Remuneration for Overtime Services Rendered*," whichever is applicable.
6. It is understood that in the conduct of this activity, there shall be no discrimination on account of age, school, gender, civil status, disability, religion, or other similar factors, or personal circumstances that run counter to the principles of equal opportunity.
