Meanwhile, uniform expenses shall be personally shouldered by the participants or may be charged to the team color funds, which may be supported by the LGU, subject to the availability of such funds.
4. Teachers involved in the activity shall be entitled to service credits for services rendered beyond office hours, on weekends, and during holidays, not to exceed fifteen (15) days, in accordance with DepEd Order No. 53, s. 2003, titled "Updated Guidelines on the Grant of Vacation Service Credits to Teachers." Meanwhile, non-teaching personnel shall be granted Compensatory Overtime Credits (COC) for services rendered beyond regular working hours, on weekends, and during holidays, pursuant to Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004, on "Non-Monetary Remuneration for Overtime Service Rendered."
