**Mechanics of the “Takbo Para sa Karera – A Color Fun Run for Career Advocacy”**

**1. Assembly and Start**

- All participants shall assemble at the Sagay City New Government Center on October 2, 2025, at 5:30 a.m.
- At the starting area, participants will be sprayed with water by the Bureau of Fire Protection (BFP) fire truck to officially signal the start of the Color Fun Run.

**2. Color Stations**

- Participants will run along the designated route passing through the following Color Stations:
  - 1st Station – Lopue’s Value Store Area (first color powder)
  - 2nd Station – New Mercury Building (second color powder)
  - 3rd Station – Sagay Water District (third color powder)
- At each station, participants will be showered with color powder/ammunition. Each color serves as a mark of passage through the station.

**3. Finish Line**

- The official Finish Line is at the Sagay City Public Plaza.
- Participants are considered official finishers if they reach the finish line with visible color markings from all stations.

**4. Safety Reminders**

- Participants must wear plain ready-to-get-wet white shirts and comfortable running attire.
- Keep valuables (phones, wallets, etc.) in waterproof covers or leave them with companions.
- Medical and security personnel will be stationed along the route to ensure the safety of all participants.
- Respect fellow runners and avoid intentional rough play.

**5. Other Provisions**

- The Color Fun Run is not a timed race; it is a celebratory and advocacy event to promote health, camaraderie, and career awareness.
- All participants are advised to bring their own water tumblers. Water refill stations will be available at the 2nd station and at the finish line.
- Participants are encouraged to enjoy, run at their own pace, and celebrate World Teachers’ Month through this meaningful and fun activity.
